A BILL

To amend the Federal Crop Insurance Act to promote crop insurance support for beginning farmers and ranchers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Crop Insurance for
5 Future Farmers Act”.

1 **SEC. 2. CROP INSURANCE SUPPORT FOR BEGINNING FARM-**
2 **ERS AND RANCHERS.**

3 (a) DEFINITION OF BEGINNING FARMER OR RANCHI-
4 ER.—Section 502(b)(3) of the Agricultural Adjustment
5 Act of 1938 (7 U.S.C. 1502(b)(3)) is amended by striking
6 “5 crop years” and inserting “10 crop years”.

7 (b) INCREASE IN ASSISTANCE.—Section 508(e)(8) of
8 the Agricultural Adjustment Act of 1938 (7 U.S.C.
9 1508(e)(8)) is amended—

10 (1) by striking “Notwithstanding” and insert-
11 ing the following:

12 “(A) IN GENERAL.—Notwithstanding”;

13 (2) by striking “is 10 percentage points greater
14 than” and inserting “is the amount of percentage
15 points specified in subparagraph (B) greater than”;
16 and

17 (3) by adding at the end the following:

18 “(B) PERCENTAGE POINTS ADJUST-
19 MENTS.—For purposes of subparagraph (A),
20 the percentage points specified in this subpara-
21 graph are as follows:

22 “(i) For each of the first and second
23 reinsurance years that a beginning farmer
24 or rancher participates as a beginning
25 farmer or rancher in the applicable policy
26 or plan of insurance, 15 percentage points.

1 “(ii) For the third reinsurance year
2 that a beginning farmer or rancher partici-
3 pates as a beginning farmer or rancher in
4 the applicable policy or plan of insurance,
5 13 percentage points.

6 “(iii) For the fourth reinsurance year
7 that a beginning farmer or rancher partici-
8 pates as a beginning farmer or rancher in
9 the applicable policy or plan of insurance,
10 11 percentage points.

11 “(iv) For each of the fifth through
12 tenth reinsurance years that a beginning
13 farmer or rancher participates as a begin-
14 ning farmer or rancher in the applicable
15 policy or plan of insurance, 10 percentage
16 points.”.
